Dear Member,

You should have received through the post a copy of one of the DVDs which was produced by the Infringement Working Group (IWG) and which were shown at the UKOPA meeting in February. Whilst you will have received a copy of one version of the DVD, I can confirm that there are two separate versions as explained and shown at the meeting i.e. one for contractors and one for landowners/tenants. The DVD was issued without a covering letter but I confirm that a note prepared by the IWG explaining the position and the ordering process by this coming weekend.
