

# Competition Law Reminder

---

“This is a meeting of competitors and competition law must be strictly adhered to both during the meeting and any breaks. Discussion should be limited to the items on the agenda, which was circulated beforehand. There should be no discussion on sharing of commercially sensitive information such as price, costs, markets, investments. Should the discussion stray onto potentially sensitive topics you should object and insist that the discussion is immediately stopped.”

---


- UKOPA is an industry group comprised of UK onshore pipeline operators
